Application

Registration

The registration will be confirmed after the registration fee has been paid. After payment you will receive a confirmation including the entrance to the online conference.

Cancellation

Canceling your registration can be done without additional costs until 30 days before the start of the IBTC. 14 days before we charge 50% of the registration fee. After this it is no longer possible to cancel your registration and you are not entitled to a refund. General
