

# General conditions IBTC 2026

## Definitions

IBTC	International Bike & hike Tourism Conference
Participants	Persons who are professionally engaged and/or involved in cycling and hiking tourism in any form whatsoever on behalf of companies, institutions or organisations and who have registered for the conference.
Organizer	Holcus Buiten BV, located in Diemen, the Netherlands
Location	Domstad Conference Center, Koningsbergerstraat 9, 3531 AJ Utrecht (10 minutes walking from Utrecht Central Station)

## 1. Application

The general conditions apply to the International Bike & hike Tourism Conference, organized by Holcus Buiten B.V.. This event will take place on Thursday the 12<sup>th</sup> of February 2026 in Domstad Conference Center in Utrecht.

## 2. Participation fee

The participation fee must be paid immediately upon online registration. This includes refreshments (coffee, tea, lunch and drinks) during the day, participation in the keynote and breakout presentations, and participation in the closing B2B program and networking drinks.

Participation fee is €225.00 per person. For exhibitors of the Fiets en Wandelbeurs this is €195.00 pp.

### Late registrations

A "late order surcharge" of €98.00 per person applies for all registrations after the 31<sup>st</sup> of January 2026.

*All prices stated here are exclusive of VAT.*

## 3. Registration

Registration for the IBTC can be done online through the link on the website [www.ibtcconference.com](http://www.ibtcconference.com).

The registration is final after the registration fee has been paid. After payment you will receive a confirmation including the entrance ticket and the invoice.

## 4. Cancellation

Before the 1<sup>st</sup> of November 2025 the cancellation costs are 25% of the paid participation fee.

From the 1<sup>st</sup> of November 2025 to the 31<sup>st</sup> of December 2025 the cancellation costs are 50% of the paid participation fee.

From the 1<sup>st</sup> of January 2026 to 31<sup>st</sup> of January 2026 the cancellation costs are 80%.

For cancellations on the 1<sup>st</sup> of February 2026 and later 100% cancellation costs will be charged.
